2018 IRS Tax Return Transcripts may be obtained by:

- GET TRANSCRIPT BY MAIL Go to www.irs.gov, click "Get Your Tax Record" and then click "Get Transcript by MAIL". Make sure to request the 2019 "IRS Tax Return Transcript", NOT the "IRS Tax Account Transcript". The transcript is generally received within 10 business days from the IRS's receipt of the online request.
- **GET TRANSCRIPT ONLINE** Go to www.irs.gov, click "Get Your Tax Record", click "Get Transcript Online". Make sure to request the 2019 "IRS Tax Return Transcript", **NOT** the "IRS Tax Account Transcript". To use the "Get Transcript Online" tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay as you go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript will display online upon successful completion of the IRS's two-step authentication and can be downloaded and printed.

■ **PAPER REQUEST FORM** – Complete IRS Form 4506T-EZ or IRS Form 4506-T. These forms can be downloaded on the www.irs.gov site. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form.

2. NONTAX FILERS

Instructions: If you and/or your spouse had little or no income earned from work in 2019 or you and/or your spouse were employed in 2019 but did not file or were not required to file a 2019 income tax return with the IRS, then you are required to provide proof of non-filing from the IRS or other relevant tax authority dated on or after October 1, 2020 that indicates a 2019 IRS income tax return was not filed with the IRS. Information on this can be found at www.irs.gov. You may also be required to complete a Methodist College Means of Support Form for Independent Students. Please contact the Methodist College Financial Aid Office to request this form. If you are unable to provide confirmation of non-filing from the IRS or other relevant tax authority, please contact our financial aid office for further instructions.
